01 November 2023	A bidi factory is operating without a permit from the Department of Environment, next to a government primary school in Jaldhaka, Nilphamari. As a result, more than 150 primary school students have suffered from respiratory problems. In this regard, the headmaster of the school said that he had written complaints to the Upazila Nirbahi Officer last year and informed the Assistant Director of the District Environment Department several times, but the problem has not been resolved so far. However, Assistant Director of the District Environment Department, Kamal Kumar Barman, said that two notices have already been sent to the owner of the Bidi factory to close the factory.
